CANCELLATION POLICY

Club Crabtowne, Inc. (CCI) is a not-for-profit organization that arranges trips and activities for the enjoyment of its members/guests. All members/guests and nonmembers must conduct themselves in accordance with the club policies. All participants must be current Club Crabtowne, Inc. club members or the guest of a member. Payment for guests must be on a member's check or a participant may be a Blue Ridge Ski Council affiliated club member. Non-members add fee to cost or join club, \$30.00.

CCI Cancellation/Refund Policy: If a participant of a CCI event withdraws from the event, the CCI will refund any monies prepaid by participant that CCI is able to recover from the event's vendor/contractor, less cancellation fee (15% of cost up to \$30.00). All vendor/contractors cancellation policies apply first, and then the Standard Club Policy applies. Refunds will not be made until after the event is completed and all financial transactions are completed with the club treasurer. All fees and monies remaining from each cancellation are the property of the club and may not be spent by the Trip Leader. Any replacements for a Club member who cancels, must be eligible to participate in the event under the rules of the CCI, and must be taken in order from the wait list. If CCI cancels an activity, refunds will be distributed from available funds from that activity. Specific prepayment requirements and cancellation penalties will vary with each event.

Trip deposit check and signature on the event application AND signature on Waiver (below) must accompany this application. This application may be completed at a General Meeting or sent in the US mail. No application may be e-mailed or faxed. Applicants will be placed on the sign-up sheet as received by leader and a wait list will be established as necessary.

WAIVER OF LIABILITY & ASSUMPTION OF RISK AGREEMENT

Whereas, the undersigned, recognize that Club Crabtowne, Inc., also referred to as the Club, is a not-for-profit organization whose primary purpose is the promotion of skiing, and other social and sporting activities, for the benefit of its members, and their guests, and

Whereas, I understand that some of the Club sponsored activities carry an inherent risk and may pose a danger to my health or safety, from accidents and unforeseen hazards, I freely and voluntarily undertake the risks involved in such activities and agree to release and hold harmless from any and all liability for my death or injury, or injury to or loss of my personal property, Club Crabtowne, Inc., its officers, Board of Director, collectively as well as individually, and trip or activities leaders.

Further, as a condition for being allowed to participate in the trip designated as _____ beginning _____ and ending _____. I agree that I shall not bring any legal action, either administrative or judicial, against Club Crabtowne Inc., its officers, Board of Directors or the leaders of a trip or activity for any of the above mentioned losses to me.

Since many trips and activities involve travel to other states and foreign countries, I agree that the laws of the State of Maryland shall govern the interpretation of this agreement/waiver of liability, and that any action must be brought in the courts of Maryland.

I also accept, as my continuing responsibility, the duty to acquaint myself with the hazards and physical demands upon my person which may be required of me during this trip and the activity (skiing, boating, etc.). If at any time during the trip, I feel that I am not capable of successfully undertaking a particular activity I shall not participate in that activity.

And in case of personal injury/accident while on a trip/activity with Club Crabtowne, Inc.; I understand that Club Crabtowne, Inc. takes no responsibility for a member, guest or non-member, personally or monetarily in the case of hospitalization, medical assistance, hotel or travel expenses that I incur as a result of my participation in the trip/activity. Trip Insurance may be offered on larger/overnight trips for your purchase, over and above the cost of the trip/activity.
